COMMON MESSAGING/PRESENTATION

Presentation needs some tweaking with new view on V1 dates.

WEBSITE

- We will launch new and improved SPDX.org coincident with LinuxCon.
- It will share DB with FOSSBazaar.org and will simply provide a different view.
- Going forward we will direct people to SPDX.org as entry point.
- From that point, SPDX discussions, drafts, minutes, etc. will be open to anyone who self-creates and account. However, because we have not worked in that way to day, minutes from meetings prior to this date will be archived and not made public.

RELEASE STATUS

- We agreed that the state of the spec is such that we anticipate lots of feedback and suggestions for improvements to the first release.
- So we concluded that we would call this Version 1 beta.
- We will solicit public comment and feedback that we will role into our V1 release in Q4.
- Official Position (in case anyone asks):
 - Coincident with the announcement of the Linux Foundation's Open Compliance Program, the SPDX Working Group will be making public Version 1 beta of the SPDX spec. At the same time, the working section of the <u>SPDX.org</u> will be opened to the public. The group encourages public comment, particularly prior to September 30 and will officially release Version 1 in Q4, the original target timeframe for release.

RELEASE READINESS

 As described above there was substantial discussion about the readiness of the spec and agreement that we are close to ready for prime time, but really need more outside feedback. Ergo, beta now, V1 in Q4, which was our original goal.

DISJUNCTIVE/CONJUNCTIVE LICENSES

- There was discussion about the meaning of CONJUNCTIVE and of DETECTED LICENSES vs. Declared. We will clarify in INTENT fields.
