Technical Agenda

RDF

Gary and Bill have been working together on examples that are now posted on the Wiki. We were able to validate the RDF syntax in one example using an online RDF validator; we'll build on this kind of tool to allow SPDX-specific validation. Proposal is to set up URLs on SPDX.org to hold references (e.g. the license short names). RDF clearly lacks some human readability, but Bill will work on a tool to create different (e.g. easily human readable) formats from SPDX source.

Short Names

Kate walked thru a draft short name list which she based on OSI approved licenses, Fedora names, Debian names, and Kim's proposal. (to be posted on Wiki) She more or less stuck with Kim's naming convention (NAME-X.Y), however because of the common use of GPLvX, retained that format for the GPL family of licenses. Much of the discussion was about that inconsistency and we explored options ranging from being completely consistent with the hyphen approach to being completely consistent with the "v" approach. In the end we decided to stick with treating GPL exceptionally, however acknowledged this could still be opened for discussion on the mailing list.

We had some discussion about the composition of the list. Basically everyone is in agreement, but we tasked Bill and Daniel with reviewing to make sure we weren't missing any obvious popular licenses.

We also spent a little time on the BSD license and decided it needed to be broken down further. Tom will make a proposal.

Other resolutions:

- No dupes in left column, i.e. each short name should apply to only one full named license.
- For any full name that contains a version number, that number will be included in the short name.
