#### **Member Counsels**

Rockett reported that he's spoken to some, not all. Current plan is to put a proposal forward and ask for comment from members.

### TradeMark and URL

Motorola will conduct and fund TM search for SPDX. Rockett will circulate the "hits" for review.

Rockett is working to resolve the filing fees, and feels that, in concept, it makes for these to be funded by the group companies or the Linux Foundation. He is also discussing with Jim Zemlin making LF the escrow agent.

The group agreed that we should ideally have a unique domain, rather than only being a sub-domain to the Linux Foundation. Assuming SPDX turns out to be a good mark we can buy spdx.com or maybe spdx.net, and spdx.org appears available.

### Wiki

Kate posted guidelines for commenting. She also added comments from Jack and Martin's older emails. The plan is to go through the Wiki at the Face to Face next week.

### "Declared" nomenclature

We decided to use "Declared," and Kate has updated the spec on the Wiki. She will add a mechanism for specifying the source of the declaration. Potentially we need to extend the spec to accommodate a chain of declarations.

### Kim's Document

At a high level Kim proposed aligning with the way Debian handles short names to improve on the Fedora names. Tom Callaway was not the call to explain Red Hat's logic, so asking for his input was requested. The most difficult issue is handling license variations and that will be on next week's agenda.
